

## Authority Mission Statement and Performance Measurements

**Name of Public Authority:** Schoharie County Capital Resource Corporation

### **Public Authority's Mission Statement:**

The Schoharie County Capital Resource Corporation (SCCRC) mission is to promote economic development and opportunities within the non-profit sector of Schoharie County. The SCIDA will do this by offering financial assistance through grant funding, bond financing, low interest rate financing, and real property and sales tax benefits to startup businesses creating jobs and existing businesses that want to expand while retaining and creating additional jobs. By utilizing the statutory powers of the Agency as set forth under the provisions of New York State laws, SCIDA will provide assistance and collaborate with Schoharie County's local government bodies and community support organizations to establish and sustain economic vitality in Schoharie County.

The SCCRC stakeholders include the following: (1) The Schoharie County Board of Supervisors, (2) The residents of Schoharie County and taxing jurisdictions, (3) Businesses currently located and businesses intending to locate in Schoharie County, (4) Not-for-profit organizations of Schoharie County, (5) The local workforce, (6) The State of New York.

The SCCRC stakeholders expect the Agency's executive director and staff to carry out the business of the Corporation in a manner that achieves the mission statements intentions.

#### **2020/2021 fiscal year measurement/goals:**

- The CRC has kept active and remained accessible to businesses.

- Continue to assist and monitor the SUNY Dormitory project and file required reports.
